1. We are committed to promoting and supporting environments which:

- a) ensures that all people feel welcomed, respected and safe from abuse;
- b) protects those vulnerable to domestic abuse from actual or potential harm;
- c) recognises equality amongst people and within relationships;
- d) enables and encourages concerns to be raised and responded to appropriately and consistently.

2. We recognise that:

- all forms of domestic abuse cause damage to the survivor and express an imbalance of power in the a) relationship.
- b) all survivors (regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity) have the right to equal protection from all types of harm or abuse;
- domestic abuse can occur in all communities; c)
- d) domestic abuse may be a single incident, but is usually a systematic, repeated pattern which escalates in severity and frequency;
- domestic abuse, if witnessed or overheard by a child, is a form of abuse by the perpetrator of the e) abusive behaviour;
- f) working in partnership with children, adults and other agencies is essential in promoting the welfare of any child or adult suffering abuse.

Types of Domestic Abuse: 3)

The following list includes the more common forms of domestic abuse but is not exhaustive:

- a) physical violence;
- b) sexual violence;
- c) emotional violence;
- d) psychological violence;
- e) spiritual violence;
- f) cultural violence;
- g) verbal abuse;
- h) financial abuse.

4. We will endeavour to respond to domestic abuse by:

- valuing, listening and respecting both survivors and alleged or known perpetrators of domestic abuse in a) all our activities;
- b) raising awareness about other agencies, supporting services, resources and expertise, through providing information in public and women-only areas of relevance to survivors, children and alleged or known perpetrators of domestic abuse in our publicity;
- when concerns are raised c)
 - (i) ensuring that those who have experienced abuse can find safety and informed help;
 - (ii) working with the appropriate statutory bodies during an investigation into domestic abuse, including when allegations are made against a member of the church community.

d) in our care -

- (i) ensuring that informed and appropriate pastoral care is offered to any child, young person or adult who has suffered abuse;
- (ii) identifying and outlining the appropriate relationship of those with pastoral care responsibilities with both survivors and alleged or known perpetrators of domestic abuse.
